#### The Sunday Law Movement - Past

I wish to God we had more Methodist churches, and more Baptist churches, and more Catholic churches," Obion County attorney general J. R. Bond told the jury, "but in the name of God, I do not want any of these Advent churches. - WEGW 113.2






#### Neighbours File Case for Working on Sunday

Robert M. King, a new convert to Adventism, was being tried for ploughing his cornfield on Sunday. Several months earlier, his Methodist neighbours—fearing that King's example would confuse their children as to which day really was the Sabbath—had demanded that he either quit keeping Saturday or move away from the Tennessee community in which he had lived all his life. If he did not start to observe Sunday, they threatened, he would be prosecuted. - WEGW 113.3

Insisting on his right to observe God's law in accordance with his understanding of the Bible, King replied that being a poor man, he could not afford to forfeit one sixth of the time he needed to support his family. - WEGW 113.4

King's non-Adventist neighbours had violated the law by hunting, fishing, and labouring on Sunday without being prosecuted. But when King had quietly gone out to cultivate a field of corn "so tall ... as to nearly hide him from sight," he had been promptly arrested. After paying \$13 in fines and costs, he had again been indicted—this time on the grounds that his Sunday ploughing had been a public nuisance. -WEGW 113.5




# Testimony of Defence not allowed in court

The court had not allowed the defense to produce testimony that King had already paid a fine for working on June 23, 1889. Nor had it permitted the introduction of evidence that King was a member of an organization that observed the seventh-day Sabbath or that the prosecution had singled out Seventh-day Adventists for arrest while ignoring Sunday law violations by others—including at least one of the witnesses. - WEGW 114.1

Even though his lawyer had not been allowed to use King's church membership as a defense, the prosecuting attorney was permitted to use it to arouse prejudice against the defendant. Deliberately confounding Adventism and Mormonism, Bond declared that "all those fellows" should be hanged. "Not satisfied with working on Sunday, and keeping half a dozen women," he raged, "they come down here and want to save us, and have us keep half a dozen women." - WEGW 114.2 Although all the witnesses had conceded that the only way King's work had disturbed them was by offending their

King's work had disturbed them was by offending their religious feelings, the jury found him guilty and fined him \$75 and costs—a staggering amount for a man in his financial position. - WEGW 114.3



#### Sabbath keeper Jailed for working on Sunday

Before the implementation of his sentence, King was once again arrested—this time for hoeing in a potato patch. Meanwhile, his wheat-cutting neighbours were unmolested. Refusing to pay both fines, King was jailed for 23 days before being released on a writ of habeas corpus. - WEGW 114.4

From prison he wrote, "It seems strange to me that I have to lie in jail for working on Sunday, when I can look out from here on Sunday and see people at work close enough to [holler] at, and nothing [is] said about it. Last Sunday they hauled wood here to a brick kiln, four or five men working all day. But of course, they were not Adventists." -WEGW 114.5








#### Found favour with honest, sincere men

U. S. district judge E. S. Hammond was inclined to believe that King had been wrongfully convicted under a non-existent law, but he said the federal courts were powerless to interfere. Denying Dickinson's contention that the Fourteenth Amendment of the U. S. Constitution limited the states in the same way as the First Amendment limited the federal government, he asserted that the Founding Fathers had left to the states the right, "if they chose, to establish a creed and a church." - WEGW 114.7

King was not the first Adventist to be jailed for Sunday labour, nor was he the last. Between 1885 and 1896, more than 100 Seventh-day Adventists in the United States were prosecuted for working on Sunday. They paid \$2,269.69 in fines and court costs, spent 1,438 days in jail, and served on chain gangs 455 days. A large share of these prosecutions took place in the Southern and border states especially Tennessee and Arkansas. - WEGW 115.1



#### **Protestants persecuting Sabbath Keepers**

Seventh-day Adventists living in the vicinity of Springville, Tennessee, were being arrested for Sunday law violations at least as early as 1879 and as late as 1892. The 1879 arrests, instigated by D. T. Clement, a Methodist minister, had not led to convictions, as the justice considered enforcing Sunday legislation upon Saturday keepers to be unconstitutional.

However, W. H. Parker, another Springville SDA, was less fortunate six years later. Charged in 1885 with "maintaining a nuisance by working on Sunday," Parker was fined \$20 and costs, although the maximum legal fine in Tennessee for Sunday law violations was \$3. The higher fine was a result of the charge of "nuisance," despite the lack of evidence that he had disturbed anyone. - WEGW 115.2



#### Jailed even when No offence to anyone

When the case was appealed, the Tennessee Supreme Court upheld the conviction, declaring that a succession of offenses against the Sunday law became an indictable nuisance even without evidence "that any person was disturbed thereby." "It is sufficient that the acts have been open to the observation of the public," the court said. "Their tendency is to corrupt public morals." - WEGW 115.3

Parker refused to pay the fine and costs, which by then amounted to \$69.81. He believed that paying the money would, in effect, be acknowledging the justice of the conviction. He chose instead to spend 280 days in jail. This decision cost him his life, because he died from malaria contracted in the filthy prison. -WEGW 115.4



#### Family members asked to report of each other

When the sheriff told the judge he thought the men were sincere, the judge replied, "Let them educate their consciences by the laws of Tennessee." - WEGW 116.5

Someone in authority decided that jail was not good enough for these men. In what must have been, in that time and place, a calculated insult, three of the men were assigned to a chain gang with three Blacks who had been convicted of shooting, drunkenness, and fighting. Instructed to require the Adventists to work on Saturday, the sheriff refused. - WEGW 116.6

The attorney general vowed that at the next court term he would have every man in the local Adventist church indicted. The prisoners had hardly returned to their homes before church members, their children, and their neighbours were summoned before the grand jury to tell about what Sunday work they had observed their fathers, mothers, sisters, and neighbours performing in their houses and fields on Sundays. As a result, 14 members of the little SDA congregation were indicted for nuisance. - WEGW 116.7



#### Jesus foretold of this - Matthew 10:21-22

The authorities planned to conduct the trial in much the same manner as the grand jury hearings. A father was called to testify against his sons. Boys—one of them only 10 years old—were summoned to testify against their fathers, and brothers were subpoenaed to testify against each other. - WEGW 117.1 **Baltimore University law professor James T. Ringgold volunteered to defend the Adventists**, with the assistance of W. L. Carter, a local lawyer who had previously been a justice of the peace. The defense invited a former governor and a former senator to attend the trial. The presence of these distinguished visitors apparently moderated the conduct of the attorney general and the judge. Handicapped by the necessity of behaving in an acceptable manner before a judge who was trying to maintain the appearance of conducting a fair trial, the prosecuting attorney finally declared, "The state confesses a verdict of not guilty." - WEGW 117.2

#### Jailed for not attending on Saturday

A Maryland Adventist was jailed and fined for refusing to testify in court on Saturday. The judge said that according to Maryland law only Sunday should be observed as the Sabbath. A Methodist pastor who had lost several members to the SDA Church saw John Judefind, another Maryland Adventist, husking corn 250 yards from the road. The pastor swore out a warrant for Judefind's arrest. Although the fact that it was issued on Sunday should have invalidated the warrant, Judefind was convicted, and the state's supreme court upheld the conviction. - WEGW 119.2 Seventh-day Adventists and Seventh Day Baptists living in Pennsylvania, Texas, California, and Rhode Island were hauled into court for Sunday law violations. Large numbers of Jews were also arrested for "Sabbath breaking" in several states—especially New York. - WEGW 119.3





#### Saturday keepers arrests no co-incidence

Was it simply coincidental that this wave of Saturday keepers' arrests occurred simultaneously with an intensive campaign for the enactment of additional Sunday laws and the stricter enforcement of the Sunday legislation already on the books? Many opponents of Sunday legislation believed that it was no coincidence. As they perceived it, the Sunday law movement was conceived in bigotry and espoused principles that would inevitably result in the suppression of religious minorities. - WEGW 119.4

On the other hand, supporters of the Sunday law movement frequently described it as a humanitarian enterprise undertaken on behalf of the overworked labourer. What was the truth? What were the real motives and tendencies of the Sunday law movement? How did the organizations that led in this movement come about? - WEGW 119.5

He was a key participant in the <u>1888</u> <u>Minneapolis General Conference</u> <u>Session</u> regarded as a landmark event in the <u>history</u> of the <u>Seventh-day</u> <u>Adventist Church</u>.



The Digital Dollar Project is a partnership between Accenture (NYSE: ACN) and the Digital Dollar Foundation to advance exploration of a United States Central Bank Digital Currency (CBDC). The purpose of the Project is to encourage research and public discussion on the potential advantages of a digital dollar, convene private sector thought leaders and actors, and propose possible models to support the public sector. The Project will moderate programs with interested stakeholders to measure the value of and establish practical steps that can be taken to establish a digital dollar.

The Digital Dollar Project (DDP) will launch at least five pilot programs over the next 12 months with interested stakeholders and DDP participants to measure the value of and inform the future design of a U.S. central bank digital currency (CBDC), or "digital dollar."



#### **Country Living - Introduction**

#### When to move to the countryside as led by God, if we ask Him for His leading?

When God created Adam and Eve, He placed them in the Garden of Eden and blessed them with the words "Be fruitful and multiply; fill the earth and subdue it" (Genesis 1:28). That garden was "a representation of what God desired the whole earth to become."


After the Fall, the population of the earth grew significantly, and cities began to flourish. Under God's guidance, Joshua distributed the settlements of Canaan among the Israelite tribes (Joshua 13– 21). Jerusalem eventually became the religious centre of Israel and the city in which the Lord placed His own name (2 Samuel 7:13; 2 Kings 21:4). What about the cities of our end-time world? How should we relate to them? Searching the Bible and the writings of Ellen White, one notices an intriguing tension between *living in* the cities and *leaving* the cities. **Let's reflect briefly on this tension.** 



# LIVING IN CITIES

The Bible mentions faithful people who lived in cities. Joseph, for example, was prime minister in the court of Pharaoh, and must have lived in the capital city (Genesis 41:44; 44:4). Daniel and his associates served in the court of Babylon (Daniel 2:49; 6:1-3). As an itinerant missionary, Paul went from city to city (Acts 20:18-24), and finally dwelt two whole years in his own rented house in Rome (Acts 28:16, 30).

Jesus told His disciples that Jerusalem would be destroyed, and they would eventually have to flee (Luke 21:20, 21). They didn't leave the city for the sake of their own spirituality. Rather, they remained there and preached the gospel so convincingly that even the high priest recognized, "You have filled Jerusalem with your doctrine!" (Acts 5:28). Only severe persecution expelled many of them from the city, leaving them to preach the gospel elsewhere (Acts 8:1, 4).



# **LEAVING THE CITIES**

The Bible also mentions families who moved from cities into more remote areas. Abraham and his family, for example, went from Ur of the Chaldeans to the land of Canaan (Genesis 11:31; 12:1-4). Lot and his two daughters left Sodom and dwelt in the mountains near Zoar (Genesis 19:15-17, 30). Following Christ's warning (Luke 21:20, 21), Christians living in Jerusalem left the city when a Roman siege was providentially interrupted. None of them perished as a result.

Over the years, Ellen White encouraged church members to move from cities to rural areas: In 1906, she stated, "More and more, as time advances, our people will have to leave the cities. For years we have been instructed that our brethren and sisters, and especially families with children, should plan to leave the cities as the way opens before them to do so."




#### The time will come when such a move is imperative

"As the siege of Jerusalem by the Roman armies was the signal for flight to the Judean Christians."

A well-planned move from the city into a rural area can bring us closer to God's original plan for humanity. But it should never weaken our missionary endeavours and lead us to a self-centred form of religion. Our mission to the cities is not finished, and we cannot become modern Jonahs (Jonah 1:1-3).

Indeed, we should be driven by Paul's unconditional commitment: "But none of these things [chains and tribulations] move me; nor do I count my life dear to myself, so that I may finish my race with joy, and the ministry which I received from the Lord Jesus, to testify to the gospel of the grace of God" (Acts 20:24).



# Leaving the Cities! Is It Biblical?

Who was the first to talk about the cities after the flood?

1<sup>st</sup> mention is Nimrod built the cities.
Genesis 10:8-12 -

And Cush begat Nimrod: he began to be a mighty one in the earth. He was a mighty hunter before the LORD: wherefore it is said, Even as Nimrod the mighty hunter before the LORD. And the beginning of his kingdom was Babel, and Erech, and Accad, and Calneh, in the land of Shinar. Out of that land went forth Asshur, and builded Nineveh, and the city Rehoboth, and Calah, And Resen between Nineveh and Calah: the same is a great city.

God is withdrawing His Spirit from the wicked cities, which have become as the cities of the antediluvian world and as Sodom and Gomorrah.... Costly mansions, marvels of architectural skill, will be destroyed without a moment's notice when the Lord sees that the owners have passed the boundaries of forgiveness. The destruction by fire of the stately buildings, supposed to be fireproof, is an illustration of how in a short time earth's architecture will lie in ruins. - LDE 112.1

Men will continue to erect expensive buildings, costing millions of money. Special attention will be called to their architectural beauty and the firmness and solidity with which they are constructed, but the Lord has instructed me that despite the unusual firmness and expensive display, these buildings will share the fate of the temple in Jerusalem. - LDE 112.2

O that God's people had a sense of the impending destruction of thousands of cities, now almost given to idolatry. - LDE 111.4 The time is near when large cities will be swept away, and all should be warned of these coming judgments. - LDE 111.5



#### Are You Ready and Prepared For What's Coming?



#### C. Water

- a. Is there sweet well water, not too deep?
- b. Is there a surface stream or spring or pond or creek?
- c. Do you have water rights?
- d. Hand well pump and a rain barrel
- e. Need a lot of water for drinking, bathing, dishes, washing clothes, gardening, cooking, and cleaning jobs.



#### **D. House**

a. Privacy

- b. Livable with minimal repairs
- c. Is the soil the kind you can have a septic?
- d. By a few S.D.A. friends?
- e. A few non-hostile neighbours in area?
- Check out what's in the area.
- What are neighbours like? Druggies? Drunks? Friendly?
- f. Check out easements
- Are there public roads or driveways crossing your property; will you have to maintain the road to your place?
- Are there large power lines or pipe lines?
- g. Have several acres away from neighbours. The more the better.

A. <u>Fruit Trees</u> - A variety of fruits grown in your area

B. **Berry Bushes** - A variety of berries

C. <u>Variety of Things for Your Area</u> – Peanuts, Grape vines, Asparagus


D. <u>Herb Garden</u> - A variety of what is grown in your area

H. <u>Outhouse</u> - At least 25 feet from the house



## What to Put On Your Property

I. <u>Woodstove</u> – Poker, Shovel, Bucket for ashes

J. <u>Cast Iron Pans</u> - Skillets and lids, Pans and lids, Cookie sheet

K. <u>**Root Cellar**</u> - To store garden things, fruit, canning, etc..

L. <u>Greenhouse</u> - To grow things during winter months

M. <u>Candles or Kerosene Oil Lamps</u> – Wicks, Matches, cigarette lighters

N. <u>Canning Jars and Extra Lids and Rings for Jars</u> -Salt (for canning)

O. <u>Hand-Powered Mill</u> - for Grinding Flour or Meal



In addition to its health and spiritual benefits, a country environment keeps families away from the corrupting influence of large cities. <u>Ellen White explained</u>: "The enemy of righteousness has every kind of pleasure prepared for youth in all conditions of life; and they are not presented alone in crowded cities, but in every spot inhabited by human beings." "But in the large cities his power over minds is greater, and his nets for the entanglement of unwary feet are more numerous."

The decision to move out of the cities is an individual (and family) matter, not one that should be forced on others. It should be prayerfully considered, taking into account overall conditions and implications, counselling with others, and faithfully following the leading of conscience.

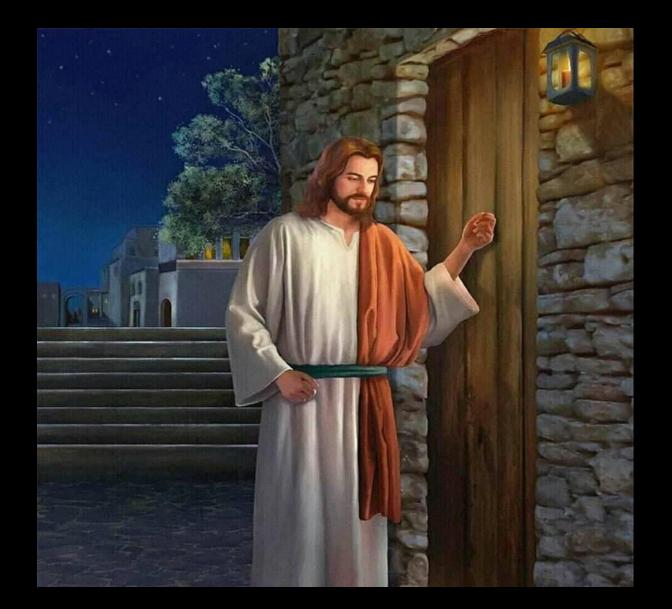
